Ladies and Gentlemen:

I would like to participate in the 2004/2005 CU Entrepreneurs £1K Business Creation Competition. The purpose of the Competition is to choose the best executive summaries prepared by members of Cambridge University Entrepreneurs (CU Entrepreneurs) and to foster entrepreneurial activities within the University and surrounding area.

I understand that in the course of my participation in the Competition I may have access to executive summaries of business plans of entrants, whether in hard copy or electronic form. These Plans may contain the ideas, inventions and concepts (collectively "Ideas") of entrants in the Competition. I understand that all intellectual and other property rights of all entrants will remain unaltered as a result of entering the Competition. I also understand that some of these Ideas or Plans may constitute trade secrets and that entrants may not have yet taken appropriate steps to patent or otherwise protect their Plans or Ideas. In consideration of my being accepted by the University of Cambridge to participate in the Competition, I agree for the benefit of the University and the individual entrants involved in the Competition I will hold Plans and Ideas which I may receive in the course of the Competition in strict confidence and will not copy, reveal, or disclose such Plans or Ideas to others and that I will not use any such Plans or Ideas for any purpose other than evaluating them with a view to submission of a joint entry with the owner of such Plans or Ideas concerned and, if agreed, the preparation and submission of such an entry.
